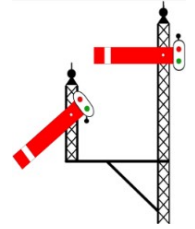

Dear Member,

Your subscription for the Society's year 2021/22 is due on **May 1st 2021**. Early payment would be appreciated as it will assist in the smooth running of your volunteer Society, whereas late payment may well result in your ceasing to receive your copy of Branch Line News in either printed or electronic format from **May 31st 2021**.

It would greatly assist your entirely voluntary Committee if members could renew, where possible, by using www.branchline.uk the Society's website or asking someone to do that for you please.

This renewal form (and website) shows the membership categories available to you and the subscription type that will be indicated on your envelope, if you receive paper printed copies.

As well as a usual printed copy, there is additionally the option of receiving an electronic version as a PDF (**e-BLN**), either: without a mailed hard copy. (**Cat. E**, equivalent to Cat. A - only available in this format), or: in addition to your mailed copy at no charge. Members can only gain access to e-BLN via the website.

If you opt for any of the electronic options, it is essential that you accurately and clearly give your email address. Even if you only have the e-BLN, please include your full postal address for any publication posted to you.

The Basic membership (Cat. D) provides for full rights to the Society but not receipt of its publications, e.g. when a full member is within your family. Please give details below of those to whom this applies.

Please indicate:

- 1) if you have changed either your existing service type or address.
- 2) if you require a receipt - in which case, please enclose an SAE.
- 3) if you require a copy of the Constitution - in which case, please enclose an SAE.

Please make your choice for the year overleaf, read the notes above and remit your appropriate payment.

Please enclose a separate sheet if there are any comments or criticism you have concerning the Society's organisation, publications or activities. The Committee is always keen to know of the views of its members and will try to meet those views in terms of how the Society is run and the services it offers.
